- a. the Directorate of Syariah Banking, M.H Thamrin Street No. 2, Jakarta 10110 in the case of BPRS having head offices win the working area of the Head Office of Bank Indonesia; or
- Local Bank Indonesia Offices, in the case of BPRS having head offices outside the working area of the Head Office of Bank Indonesia.

VI. CONCLUSION

The circular comes into force as from the date of stipulation.

DECIDES:

To stipulate:

THE DECISION OF THE DIRECTOR GENERAL OF TREASURY AFFAIRS ON THE APPOINTMENT OF PERCEPTION BANKS/POST OFFICES OF BPHTB AND OPERATIONAL BANKS III OF BPHTB

FIRST:

In order to accommodate revenue from BPHTB, Perception Banks/Post and Giro Offices and Operational Banks III of BPHTB as contained in columns 3 and 4 of the attachment to this regulation are appointed.

SECOND:

Perception Banks/Post Offices of BPHTB (column 3) of the attachment to this regulation are obliged to:

- Open account of State Cash in this case BPHTB automatically, report and send weekly and monthly account sheet, credit note/debit note of revenue/delegation of account of State Cash in this case BPHTB to local KPPN, KPPBB/Primary KPP and Regental/Municipal Revenue Service;
- Every Friday or ensuing working-day (if Friday is holiday) in the next week, delegate all balance of account of State Cash in this case BPHTB to Operational Banks III of BPHTB.

THIRD:

Operational Banks III of BPHTB (column 4) of the attachment to this decision are obliged to:

- Open account of State Cash in this case BPHTB automatically and report to local KPPN, KPPBB/Primary KPP and Regental/Municipal Revenue Service;
- Every Friday or ensuing working-day (if Friday is holiday), receive delegation of balance from Perception Banks/Post and Giro Offices of BPHTB;
- 3. Based on General Power of Attorney from Heads of KPPBB, Operational Banks III of BPHTB every Wednesday or ensuing working day (if Wednesday is holiday), share all balance of account of State Cash in this case BPHTB and directly transferred/delegated to the righteous parties as follows:
 - a. 20% to account of State Cash A at Bank Indonesia (Sole Bank)/Operational Bank I of KPPN;
 - b. 16% to account of Provincial Cash;64% to regental/municipal cash account, exceptDKI Jakarta 80%.
- 4. Especially for the Province of Nanggroe Aceh Darussalam, the regional portion as high as 80% (eighty percent) as meant in point (3) letter b is specified as follows:

- a. 16% (sixteen) percent to the Province, shared with the ratio as follows:
 - 30% (thirty percent) to the educational fund in the Province of Nanggroe Aceh Darussalam and channeled through special account of Educational Fund;
 - 70% (seventy percent) to the Province of Nanggroe Aceh Darussalam, channeled through the Provincial Cash Account.
- b. 64% (sixty four percent) to Regencies/Cities with the ratio as follows:
 - 30% (thirty percent) to the educational fund in the Province of Nanggroe Aceh Darussalam and channeled through special account of Educational Fund;
 - 70% (seventy percent) to the Province of Nanggroe Aceh Darussalam, channeled through regental/municipal Cash Accounts.
- 5. Send weekly and monthly balance account, debit note of charge of state cash account in this case BPHTB and credit note of revenue/delegation of balance from Perception Banks/Giro and Post Offices of BPHTB to KPPN, with a copy made available to Local KPPBB/ Primary KPP and Regional Revenue Service.

FOURTH:

With the enforcement of this decision, Decision of the Director General of Treasury Affairs No. Kep-08/PB/2005 dated January 31,2005 is declared null and void.

FIFTH:

The decision comes into force as from the date of stipulation and will be rectified accordingly in the case of mistake being found.
