DECREE OF THE MINISTER OF ENERGY AND MINERAL RESOURCES OF THE REPUBLIC OF INDONESIA

NUMBER 284.K/MB.01/MEM.B/2024 OF 2024

ON

FORMULA FOR THE CALCULATION OF COMPENSATION PRICE FOR INFORMATION DATA ON MINING BUSINESS LICENSE AREA AND SPECIAL MINING BUSINESS LICENSE AREA FOR METAL MINERAL AND COAL

BY THE GRACE OF GOD ALMIGHTY

THE MINISTER OF ENERGY AND MINERAL RESOURCES OF THE REPUBLIC OF INDONESIA

Considering:

- a. that in order to optimize non-tax state revenues and take into account the metal mineral and coal commodity markets as well as to provide guidelines for the calculation of compensation prices for information data on mining business license areas and special mining business license areas for metal mineral and coal, it has been deemed necessary to regulate formula for the calculation of compensation price for information data on mining business license areas and special mining business license areas for metal mineral and coal;
- b. that for the purpose of granting metal mineral and coal mining business license areas based on the provisions of Regulation of the President of the Republic of Indonesia Number 70 of 2023 on the Allocation of Land for Investment Arrangement as amended by Regulation of the President of the Republic of Indonesia Number 76 of 2024 on the Amendment to Regulation of the President of the Republic of Indonesia Number 70 of 2023 on the Allocation of Land for Investment Arrangement, it has been deemed necessary to calculate the compensation price for information data on mining business license areas for metal mineral and coal;
- c. that as an effort to optimize state revenue, it has been deemed necessary to adjust the components in the formula for the calculation of compensation price for information data, as stipulated in Decree of the Minister of Energy and Mineral Resources Number 23.K/MB.01/MEM.B/2023 dated January 27, 2023 on Formula for the Calculation of Compensation Prices for Information Data on Mining Business License Areas and Special Mining Business License Areas;
- d. that based on the considerations as referred to in letter a, letter b, and letter c, it has been deemed necessary to establish Decree of the Minister of Energy and Mineral Resources on Formula for the Calculation of Compensation Price for Information Data on Mining Business License Area and Special Mining Business License Area for Metal Mineral and Coal.

HAS DECIDED:

To establish:

DECREE OF THE MINISTER OF ENERGY AND MINERAL RESOURCES ON FORMULA FOR THE CALCULATION OF COMPENSATION PRICE FOR INFORMATION DATA ON MINING BUSINESS LICENSE AREA AND SPECIAL MINING BUSINESS LICENSE AREA FOR METAL MINERAL AND COAL.

FIRST:

Establishes Formula for the Calculation of Compensation Price for Information Data on Mining Business License Area and Special Mining Business License Area for Metal Mineral and Coal as listed in the Appendix which constitutes an integral part of this Decree of the Minister.

SECOND:

Upon the effective enforcement of this Decree of the Minister, the Compensation Price for Information Data on Mining Business License Area and Special Mining Business License Area for Metal Mineral and Coal which has been determined by using Formula for the Calculation of Compensation Price for Information Data on Mining Business License Areas which are valid prior to the enforcement of this Decree of the Minister, shall remain valid as long as there is no change in the compensation price for data and information in the stipulation of Mining Business License Areas and Special Mining Business License Areas.



THIRD:

Upon the effective enforcement of this Decree of the Minister, Decree of the Minister of Energy and Mineral Resources Number 23.K/MB.01/MEM.B/2023 dated 27 January 2023 on Formula for the Calculation of Compensation Prices for Information Data om Mining Business License Areas and Special Mining Business License Areas is repealed and declared invalid.

FOURTH:

This Decree of the Minister comes into force on the date of its establishment.
