ASSIGNMENT AT SUB-DISTRIBUTORS IN UNDERDEVELOPED, FRONTIER, OUTERMOST, OR REMOTE
AREAS**

**THE HEAD OF THE DOWNSTREAM OIL AND GAS REGULATORY AGENCY OF THE REPUBLIC OF
INDONESIA,**

Considering:

- a. that for the continuity of the supply and distribution of certain types of oil fuel and oil fuel for special assignment to consumer users through sub-distributors in underdeveloped, frontier, outermost or remote areas, it has been deemed necessary to extend the distribution activities of certain types of oil fuel and/or oil fuel for special assignment for existing oil fuel sub-distributors;
- b. that the transitional provisions in Regulation of the Downstream Oil and Gas Regulatory Agency Number 1 of 2024 on Distribution of Certain Types of Oil Fuel and Oil Fuel for Special Assignment at Sub-distributors in Underdeveloped, Frontier, Outermost, or Remote Areas is no longer in accordance with the needs of the community, thus needs to be amended;
- c. that based on the considerations as referred to in letter a and letter b, it has been deemed necessary to establish Regulation of the Downstream Oil and Gas Regulatory Agency on the Amendment to Regulation of the Downstream Oil and Gas Regulatory Agency Number 1 of 2024 on Distribution of Certain Types of Oil Fuel and Oil Fuel for Special Assignment at Sub-distributors in Underdeveloped, Frontier, Outermost, or Remote Areas;

Observing:

HAS DECIDED:

To establish:

REGULATION OF THE DOWNSTREAM OIL AND GAS REGULATORY AGENCY ON THE AMENDMENT TO REGULATION OF THE DOWNSTREAM OIL AND GAS REGULATORY AGENCY NUMBER 1 OF 2024 ON DISTRIBUTION OF CERTAIN TYPES OF OIL FUEL AND OIL FUEL FOR SPECIAL ASSIGNMENT AT SUB-DISTRIBUTORS IN UNDERDEVELOPED, FRONTIER, OUTERMOST, OR REMOTE AREAS.

Article I

Provisions of Article 14 in Regulation of the Downstream Oil and Gas Regulatory Agency Number 1 of 2024 on Distribution of Certain Types of Oil Fuel and Oil Fuel for Special Assignment at Sub-distributors in Underdeveloped, Frontier, Outermost, or Remote Areas (Official Gazette of the Republic of Indonesia of 2024 Number 319) have been amended, therefore it reads as follows:

Article 14

BBM Sub Distributor that has existed before the promulgation of this Regulation of the Agency:

- a. may conduct the distribution of Certain Types of Oil Fuel and/or Oil Fuel for Special Assignment until 30 September 2025; and
- b. in the case of continuing as a BBM Sub Distributor, must submit an application for BBM Sub Distributor in accordance with this Regulation of the Agency.

Article II

This Regulation of the Agency comes into force on the date of its promulgation.

For public cognizance, it is hereby ordered that this Regulation of the Agency be promulgated in the Official Gazette of the Republic of Indonesia.
